

Quota for Protective Steel Plates for Distribution Boxes



Overview

Full details of the changes which come into force on 1 July 2025 can be found in the Public Notice 2025/12. No rollover of unused quota between quota periods. By Implementing Regulation (EU) 2019/159 (3) ('the Definitive Regulation'), the European Commission ('the Commission') imposed a definitive safeguard measure on certain steel imports ('the measure'). 1% cut to the duty-free hot-rolled coil (HRC) quota, reducing it to 1. The new regulation is aimed at addressing the negative trade-related effects of global overcapacity on the EU steel market. The Trade Remedies Authority (TRA) initiated the tariff-rate quota (TRQ) review on 28 February 2025 of its own initiative, in accordance with regulation 35B (5) (2) (a) of The Trade Remedies (Increase in Imports Causing Serious Injury to UK Producers) (EU Exit) Regulations 2019 ('the Regulations').
